Due to COVID-19, we are obliged to change the delivery procedure to guarantee social distance.

AT THE ATTENTION OF THE BUYER

ART. 6 General Conditions

ART 53,11° WER VI

The buyers or bidders shall be deemed to have inspected all lots on the viewing day which is organised before de closure of the sale.

Participating and bidding without having inspected the lots on the viewing day, is on their own responsibility.

Art. 6.2 and 6.6 of the General Conditions mentions:

“The Lots are sold for what they are worth in the state in which they are found on the date of Allocation with all benefits and burdens attached thereto. The Purchaser is assumed to have carefully investigated the Lot bought by him beforehand. Appelboom and/or the Seller do not give any indemnity of any kind for visible or hidden defects or any kind of guarantee in connection with completeness, numbers, functioning, usability, saleability, the existence or non-existence of rights of third parties and/or the possibility of transfer to third parties. No right of discount, damages and/or any other remedies shall be available to the Purchaser with respect to defects of whatever kind or disappointed expectations of the Purchaser and/or receiving third parties. As the lots could be visited before or during the Auction and the Online Conditions were known, the Buyer is supposed to have examined carefully the lots he bought, and being informed about the state of the lots.”

“All information/mentions about the lots in the catalogue, brochures or any other communication written by Appelboom and/or the internetsite of Appelboom, nor the seller or the bailiff. Examples of such wrong mentions (but not limited to this list) can be: the numbers of kilometres, the working hours of vehicles and machineries, date of construction, the accession date and other technical or commercial specifications.”

The Law for Remote Sale determined in WER Book VI art. 53 does not apply on public auctions (11°). Buyers do not have the right to cancel or revoke cfr art 47 WER Book VI.

LOTS WITHOUT A BID

For lots without bids, in some cases the price can be lowered in the last 24 hours before the ending of the auction.
