**ART. 6 General Conditions**

**ART 53,11° WER VI**

**The buyers or bidders shall be deemed to have inspected all lots on the viewing day which is organised before de closure of the sale.**

**Participating and bidding without having inspected the lots on the viewing day, is on their own responsibility.**

No right of discount, damages and/or any other remedies shall be available to the Purchaser with respect to defects of whatever kind or disappointed expectations of the Purchaser and/or receiving third parties. As the lots could be visited before or during the Auction and the Online Conditions were known, the Buyer is supposed to have examined carefully the lots he bought, and being informed about the state of the lots.”**
